Dear KMSC Members,

We are excited for our community pool to open on Friday, June 26! We have been working hard to make this summer at KMSC both *safe* and *enjoyable*! We look forward to working with our members to make this season a positive one.

This letter includes information about the KMSC operating procedures and hours of operation following Montgomery County Reopening Phase 2 guidelines. Please know these may need to be revised as the season progresses. POOL HOURS/CAPACITY/FACILITIES:

- Sunday through Friday: 11:00AM - 3:30PM; 4:00PM - 8:30PM.
- Saturdays: 12:00PM - 3:30PM; 4:00PM - 8:30PM.
- **Pool will be closed daily from 3:30PM - 4:00PM for cleaning.** All members must leave the pool area.
- KMSC has two capacity numbers: 150 people when two lap lanes are available and 93 people when six lap lanes are available. With our current membership numbers, a **reservation system for coming to the pool will NOT be put into place.** This will be revisited and/or revised as needed.
- Adult only swim will be available the last 15-minutes of each hour, **except for** 4:00PM - 8:30PM Monday through Friday.
- County Phase 2 regulations require that the baby pool be closed.
- The water fountain, snack bar, playground, and slide will also be closed. The board may reassess these later in the summer.
- To keep use of indoor spaces at a minimum, please come prepared to swim. Changing at the pool is discouraged.
- Shower access will be for rinse-off only, before and after using the pool. Toilets will be available.
- We encourage members to bring hand sanitizer and disinfecting wipes when coming to the pool. Please dispose of these items appropriately after use.

SIGN IN AND OUT PROCEDURES:

- Only individuals listed on your membership will be permitted access to KMSC.
- **Each member** will be **signed-in upon arrival** and **signed-out upon departure** by a staff member without contact. This is required by Montgomery County.
- Only pool members (no guests) will be admitted at this time. We will reassess as the season progresses.
- One-Day passes will not be available. .

SOCIAL DISTANCING

- To help facilitate social distancing on the deck, KMSC picnic tables and chairs are arranged to support 6-ft. distancing practices and should not be moved out of their locations.
- **Masks must be worn** by everyone ages 2 years and older when interacting with staff or other individuals not from their household and when inside the clubhouse. Masks should not be worn in the water.
- Members are encouraged to wipe down chairs and tables prior to using.
- KMSC members are welcome to bring their own chairs, but may not leave them at the pool.
- Members should check they have all personal items before departing from the pool. Items that are left behind are subject to disposal. **We are not maintaining a lost and found this season.**
- While in the water, families and individuals are asked to monitor their own social distancing, since our staff cannot know which household members should be together.
- Any areas requiring a queue, such as the diving board, will have visual markers to facilitate 6-ft distancing.

FOOD AND DRINK

- Members may have food in their designated area. Food should be covered if leaving your designated area. Members must clean their area prior to departing KMSC.
- Members should bring water to the pool, since the water fountain is closed.

LAP LANES

- Six lap lanes available in the deep end of the pool Monday through Friday, 11:00AM - 1:00PM and 6:30PM - 8:30PM. Two lap lanes will be available at all other times.
- County Phase 2 regulations mandate only **one person** may use a lane at a time.
- Lanes are available on a first-come, first-serve basis. Members are asked to be mindful and keep their swim time to 30-minutes during peak times, when others are waiting. The use of sign-ups for lane use will be revisited and a reservation system will be implemented, if needed.
- The shallow end of the pool will be available during all operating hours, with proper social distancing.
